### Registration Fees

\$100/child (current enrollment)

\$125/child (new child)

Supply Fee:

\$50/child (includes t-shirt)

### Monthly Fees

(August-May)

Infants/Toddlers--\$280/month

2-3 / 3-5 Years--\$250/month

### Discounts

- Registration fees are non-refundable.
- There is a 10% discount for the second child in the same family.
- No discount is provided for drop in childcare.
- There is a 5% discount if you pay the full amount for the whole year by August 31.
- There is a 2% discount if you pay the full amount for the semester by August 31.
- Tuition is due on the 1<sup>st</sup> of each month.
- \$25.00 late fee is charged after the 5<sup>th</sup>.

### Registration/Supply Fee

- The registration fee is due with returned paperwork to reserve a spot for your child.
- There will be a \$50 supply fee due at the time of Registration (includes t-shirt).
